Terms of Use of the site Project EMPLOCOMP

1. General regulations

Please read carefully the Terms of Use before using the site of project Emplocomp (hereinafter referred to as "Emplocomp"). These terms and conditions form a contract between you and project Emplocomp by which you are entitled to free use of services of this website for personal and non-commercial purposes subject to the conditions below. These Terms are binding only in the relationship between you as a user of the services of the project site. By accessing (loading) the website, you agree to be bound by these terms and conditions and any subsequent amendments thereto, and you agree to follow them. If you do not agree with all the terms and conditions below, please do not use the site of project Emplocomp.

Users are entitled to use the services of the website called hereinafter only "site" solely for personal / non-commercial purposes. When you add a post / comment in the forums, users agree to abide these Terms of Use. The leading organization and the Partners of project "Emplocomp" are not responsible for views expressed by users.

2. Basic Concepts

For the purposes of these Terms the following notions are used with the following meaning:

"User" means any natural person who uses any of the services of any of the sites of project Emplocomp.

"SERVICE / s" on the site include:

- Access to information resources of the site through the web browser ;
- Participation in the forums of the site by commenting, grading and reporting to the moderator of published opinions;

- Creation and customization of user profiles through registration, which allows access to the information resources of the archive of the site and participation in network of users;

- Receiving an e-mail -bulletins of registered service users.

"Partner" means any entity and/or authorized by them technical persons who are partners of the project Emplocomp.

Each post in a format different from the website (such as a public screen) requires written permission from the administrators of the site of Project Emplocomp. If the other sites use the attached picture in the RSS feed, it must be accompanied by the title, the first 500 characters of the text and the author.

Disclosure is only possible when the user has submitted personal data in the fields of public information, the registration form and on the Settings page; when the information is required by state bodies or officials authorized by law to request and collect information



containing personal data and in compliance with the statutory procedure.

Emplocomp project partners can provide the statistical information on the website to the partner organizations for the purpose of internal statistics and other actions.

By accepting these Terms and Conditions, the User agrees to the processing of information provided by him in the completed registration form of personal data for the purposes of the Project site Emplocomp. The user has the right to object to the processing of personal data for the site of project Emplocomp by sending written notice to the Lead Partner by email: main@emplocomp.eu.
